The regular meeting of April 29, 2019 was called to order at 7:00 pm by John Leirmo.

All members present, John Leirmo, Al Thompson, and David Olson.

John made motion a to amend the agenda to add a review of the Sugar Creek Winery liquor license request, the Ferryville EMS annual contract, and additional roads for ATV/UTV approval. David seconded. All yes.

Gravel and Sealcoat bids were reviewed. Gravel bids were received from Gerke Excavating, Inc. , Tomah WI and The Kraemer Company, LLC, Plain, WI. David made a motion to accept the bid from Gerke Excavating for \$8.50/CU for Screenings and ¾" gravel, \$21.65/CU for Rip Rap, and \$8.25/CU for 3" Breaker and contract with The Kraemer Co for Shot Rock at \$8.75 CY or \$6.48 per ton. John seconded, All yes. John will contact Robin Davis at The Kraemer Co for the Shot Rock Contract.

Sealcoat bids were received Scott Construction, Inc. Lake Delton, WI and Fahrner Asphalt Sealers, LLC, Plover, WI. Al made a motion to accept the bid from Scott Construction for \$17,236.00 per mile 20 feet wide single seal over a hard surface and \$34,284.00 per mile 20 feet wide double seal over a hard surface. David seconded, all yes.

Patrolmen hours were reviewed. David made a motion to approve, John seconded. All yes.

Peggy certified the meeting was posted in the NEIA newspaper, River Bank, P.O., and the Town Shop.

Peggy presented the minutes from the 3/25/19 meeting. Approved as read.

The April bills were reviewed. David made a motion to approve, Al seconded. Roll call vote, all yes.
